### **DCYA Early Years Qualification Recognition Application Form**

DYCA has published a list of qualifications that meet the regulatory requirements for working in the Early Years sector in Ireland. The list can be viewed on our website.

- Early Childhood Education Theory and Practice
- Child Health and Welfare 0-6 years of age

These studies must be at a minimum of Level 5 on the Irish National Framework of Qualifications (NFQ), or equivalent.

Please note the following:

- When completing the application form, please provide a **personal** email address, not the email address of an employer.
- Please sign and date the application form (unsigned forms cannot be accepted).
- Applications can only be accepted from the individual who holds the qualification to be assessed and cannot be accepted from a third party (such as an employer or prospective employer).
- Information about the status of an application cannot be provided to a third party.
