

### HELPPPP - HOW LONG IS MY CHILD ELIGIBLE FOR THE ECCE PROGRAMME??

DCCC have been listening to your queries around eligibility for the ECCE programme. We have compiled three tables for children born in 2012, 2013 and 2014 to help explain the maximum entitlement of weeks for children born during these years and the earliest entry points. The three tables are aligned to the information provided by the DCYA (found at the end of the document), however go into more detail by breaking this down into monthly data.

The below tables are accurate as of today, with regards to special needs or exemptions, DCCC are awaiting clarification on these from the FAQ document which is being compiled by DCYA currently.

In the meantime, we hope this helps early childhood services to answer queries from parents and for parents themselves to find out their individual child's eligibility on the ECCE programme going forward.

DCCC have compiled the above three tables to better explain the entitlements each child has under the ECCE scheme, based on their birth month and the information which has been supplied by DCYA which may be subject to change.

In regards to special needs children or exemptions, this is to be referred to DCYA directly. **Rules which have been applied:** 

- ECCE 2015: 2<sup>nd</sup> February 2011 30<sup>th</sup> June 2012
- ECCE 2016: New criteria eligible from September 2016
- ECCE 2016: Entry from when a child turns 3 years old
- ECCE 2016: Staggered entry points of September, January and April of each year depending on birth month.
- ECCE 2016: All children not being older than 5 years and 6 months at the end of each pre-school year.
- All children starting school before they are 6 years old.
